### 3. Other Institutional Scholarships

- **Defence/CRPF Appreciation Scholarship for Post Graduate Students:** This award will be offered to CRPF or Defence personnel's children in appreciation of their service to the country. The scholarship amount will be 25% of the tuition fees (only for the second year's tuition fee).
- **Sports Scholarship:-** Students who participate in sports and games at the collegiate, national, or international levels will be eligible for a sports scholarship. Depending on the applicant's merit, 10% of the student's annual tuition fees will be typically provided as a sports scholarship.
- **Special Scholarship:-** A special scholarship will be offered to students who achieve at the state, board, or national level in academics as well as at the national or state level in co-curricular and extracurricular activities other than sports. Depending on the applicant's merit, 10% of the student's annual tuition fees may be provided as a sports scholarship.
- **Sibling scholarship:-** This scholarship is given to students who are siblings of IIBS Alumni or current students. These students will be eligible for a scholarship worth Rs.50,000. (After verification, the concession from any other scholarship or the sibling scholarship, whichever is higher, will be made available)
- **Disadvantaged Students Scholarship-** This scholarship will be offered to physically challenged students. The annual scholarship amount for an eligible candidate ranges between 50% to 100%
- **Free ships:** The institute also offers completely free tuition to exceptionally low-income students who excel in the academic arts, culture, and sports. The requirements for freeship will be set by the Management.

### **The procedure for application and processing of scholarships and free ships**

- Eligible applicants for Academic Merit Scholarships should send in their completed applications, along with copies of their entry-level and university grades and personal bank account information, to the scholarship support officer in the administrative office for processing before the notified last date.
- Interested students should pick up the application from the scholarship assistance officer for Financial Aid scholarships. The Head of the relevant Department should receive a properly completed application along with necessary supporting documentation.
- After carefully reviewing the application, the department head shall makes a recommendation regarding the candidate's eligibility or ineligibility for the scholarship. The department shall communicate to the Principal its decision. The final list of applicants who qualify for financial aid scholarships will be decided by the Principal and the Managing Committee. Financial Aid Scholarship applications will be open to all interested students.
- For Sports Scholarships, applications must be obtained from the Scholarship Support Officer and shall be submitted to the director of Physical Education together with the necessary supporting documentation. After carefully reviewing each application, the director shall recommend one candidate to the principal.

- For scholarships for disadvantaged students, the application shall be obtained from the Scholarship Support Officer and should be submitted to the head of the department along with the necessary supporting documentation. The department head will verify the supporting documentation and then communicate the decision to the Principal.
- The rest of the process for all other scholarships is the same as merit scholarship.
- Submission of the application for scholarship shall be at the entry level.
- Every semester, for the students receiving scholarship, their performance will be evaluated by the scholarship committee. Students must maintain 80% attendance for the duration of the whole semester in order to continue receiving the scholarship. A scholarship recipient will be put on -'Academic Probation'- and the Scholarship Committee may have their scholarship award reconsidered if they fall short of this requirement during a specific semester.
- The eligible student shall not receive direct payment from the scholarship. The semester fees will be directly deducted as per the amount of scholarship awarded.

#### **Support to Apply and Process National/State/NGO Scholarships**

- IIBS offers support to apply for and process scholarships from national, state welfare departments, and non-governmental organisations.
- A faculty member shall be given the charge of assisting students with the same, as well as to verify and approve the applications on NSP and SSP portals.
- The scholarship recipients are required to give a copy of the scholarship receipt to the scholarship support officer for records after receiving such awards.
